**Subject :** Revision in the rates of concession of gas based NPK Complex Fertilizers ( 20-20-0,15-15-15) w.e.f. 1.7.2005 to 31.3.2008, manufactured by M/s Rashtriya Chemicals and Fertilizers Ltd. (RCF), under the Concession Scheme on decontrolled P & K fertilizers due to upward revision in the price of gas under the Administered Price Mechanism (APM).

Based on the decision taken by the Government in respect of the above, I am directed to say that it has been decided to compensate M/s RCF at Rs. 7 per 'N' for production and sale of two grades of NPK Complex Fertilizers viz. 20-20-0 and 15-15-15, w.e.f. 1.7.2005 to 31.3.2008, due to upward revision in the price of gas under the Administered Price Mechanism (APM), as provided by the Tariff Commission. Accordingly the revised rate of concession for the above said gas based complex fertilizers of M/s RCF shall be as per Annexure.
