

Interested parties are requested to submit their bids mentioning therein the rates to be charged by them subject to the following conditions :-

1. The hiring charges shall be on the basis of zero based mileage i.e mileage starting/ending from/at the Office of FICC.
2. FICC shall be liable to pay the hiring charges only. Service Tax shall be paid extra on actual basis. Other liability like monthly charges of Drivers, repair & Maintenance of vehicles. Insurance, petrol/diesel oil and any other incidental expenses etc. shall be borne by the vehicle provider.
3. In case of any mishap/accident, all the claims arising out of it shall be met by vehicle provider.
4. Road worthiness of the vehicles is to be essential at all time by the vehicle provider.
5. The vehicle should be registered with the concerned authority of Central/State Government.
6. In case the condition of vehicle is found unsatisfactory, that shall be returned for immediate replacement. In case no replacement is provided on time, the Office shall have the right to hire a vehicle from the market and additional cost incurred by the authority shall be borne by the vehicle provider.
7. The vehicle provider would ensure that the driver/employee possessed a valid driving license. The driver of vehicle provided must follow traffic rules and other regulations prescribed by the Government from time to time.

8. The driver shall observe all etiquettes and protocol while performing duty and shall be neatly and properly dressed and must carry a mobile phone in working condition, for which this office shall make no separate payment.

Last date for submission of quotation is 30th September, 2009 at 1600 hours. FICC reserve the right to accept or reject any or all quotations without mentioning any reason.
