**A. Trend in International prices of fertilizers**

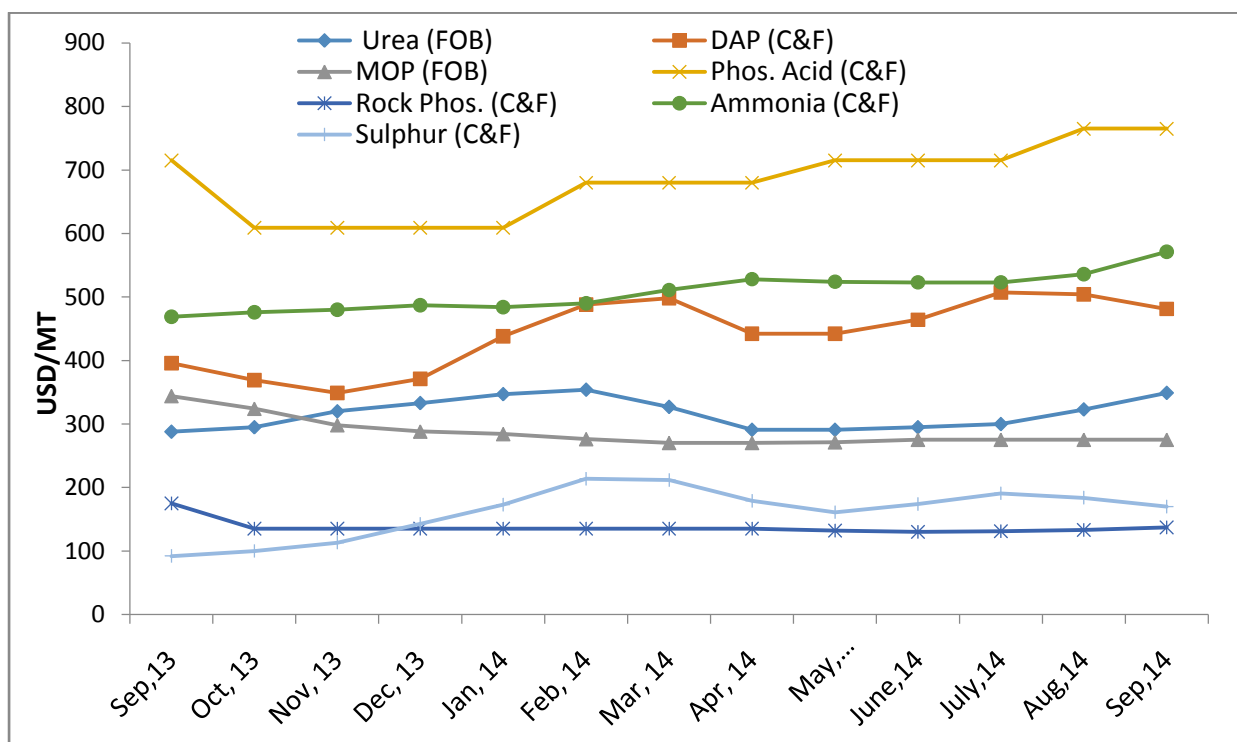

**Diagram-1: Trend in International prices of fertilizers since September, 2013**



- The price of Urea (FOB) has increased by about 21.18% from 288 USD/MT in September, 2013 to 349 USD/MT in September, 2014.
- The price of DAP (C&F) has increased by about 21.46% from 396 USD/MT in September, 2013 to 481 USD/MT in September 2014.
- The price of MOP (FOB) has shown declining trend during the period from September 2013 to September 2014 and decreased by about 20.06% from 344 USD/MT in September, 2013 to 275 USD/MT in September 2014.
- The price of Phosphoric Acid(C&F) has increased by about 6.99% from 715 USD/MT in September, 2013 to 765 USD/MT in September 2014.
- The price of Rock Phosphate(C&F) has decreased by about 21.71% from 175 USD/MT in September, 2013 to 137 USD/MT in September 2014.
- The price of Ammonia(C&F) has shown upward trend during the period from September 2013 to September 2014 and increased by about 21.75% from 469 USD/MT in September, 2013 to 571 USD/MT in September 2014.

- The price of Sulphur(C&F) has shown upward trend during the period from September 2013 to September 2014 and increased by about 84.78% from 92 USD/MT in September, 2013 to 170 USD/MT in September 2014.

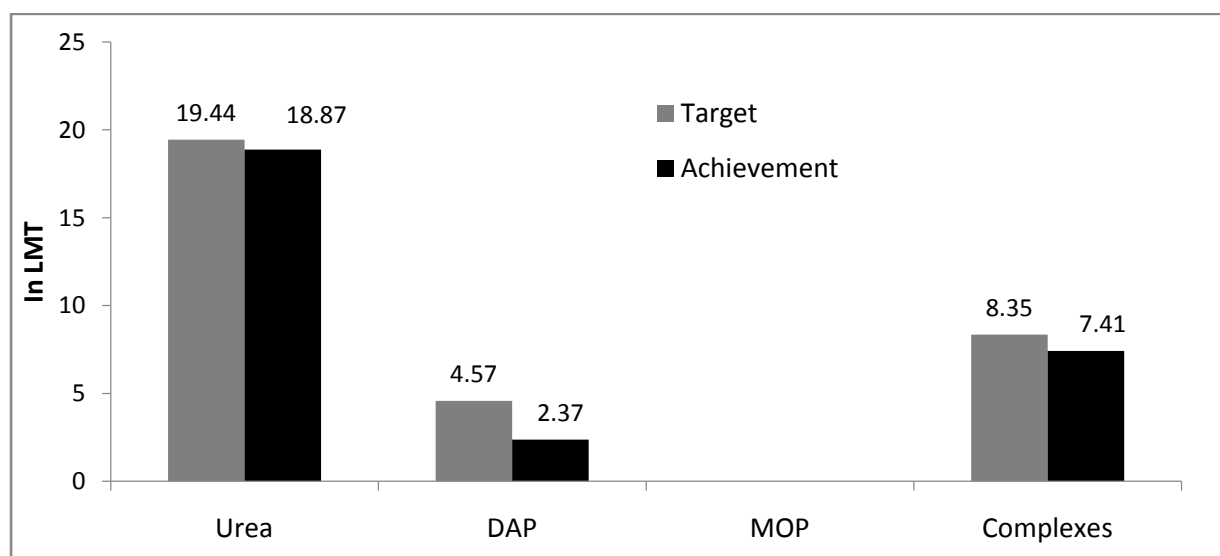

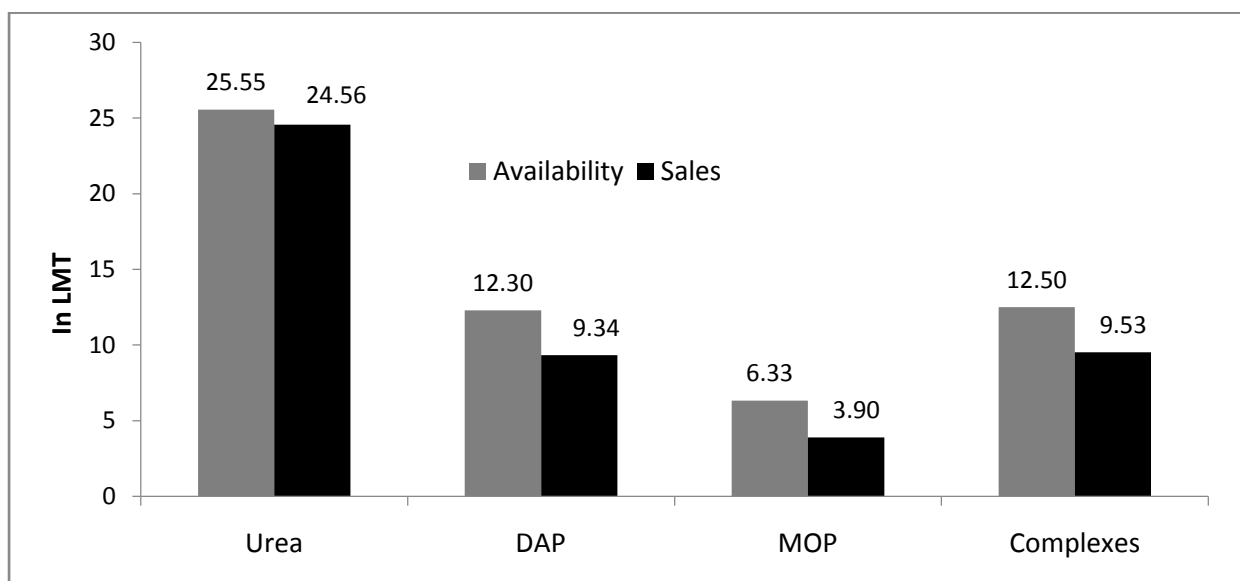

The availability of Urea, DAP, MOP and Complexes were higher than the sales during September, 2014.

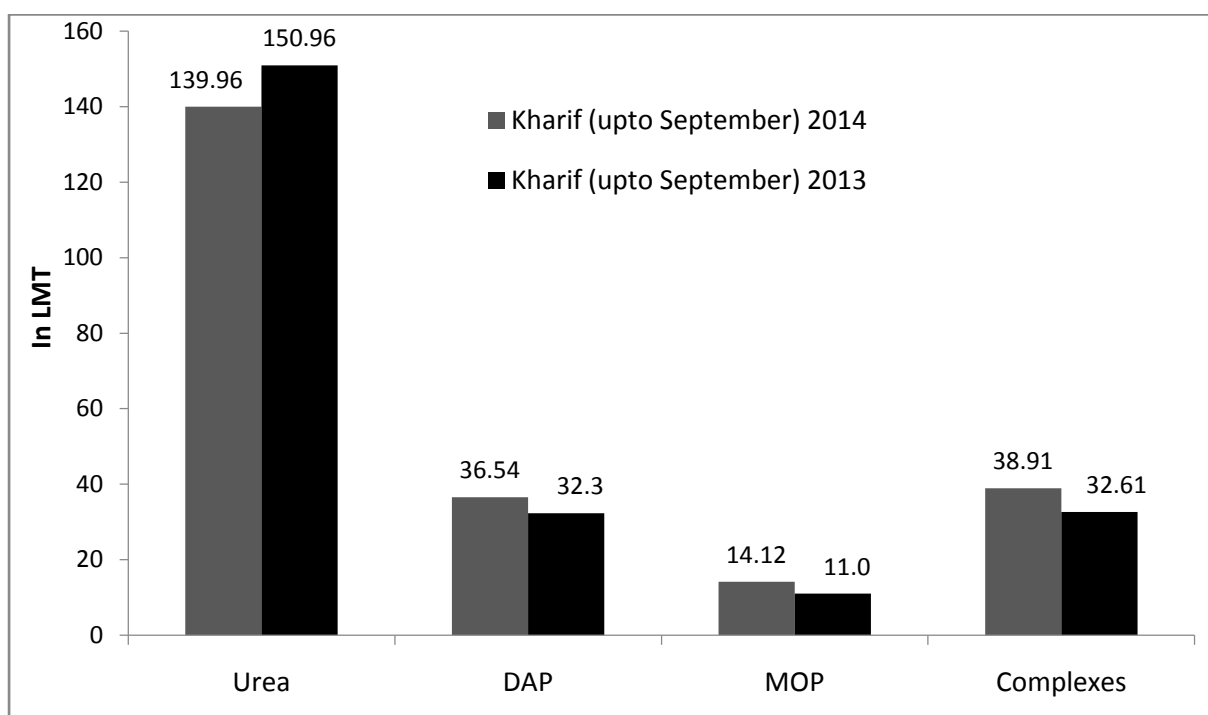

**Diagram-4: Fertilizers Sale Comparison between Kharif (upto September) 2014 and Kharif (upto September) 2013**



The sales of DAP, MOP and Complexes Fertilizers during Kharif(upto September) 2014 were higher than the sales in the same period last year. However, the sale of Urea was less in Kharif (upto September) 2014 as compared to sale in Kharif (upto September) 2013. The percentage increase in sales over last year was the highest in case of MOP followed by Complexes.

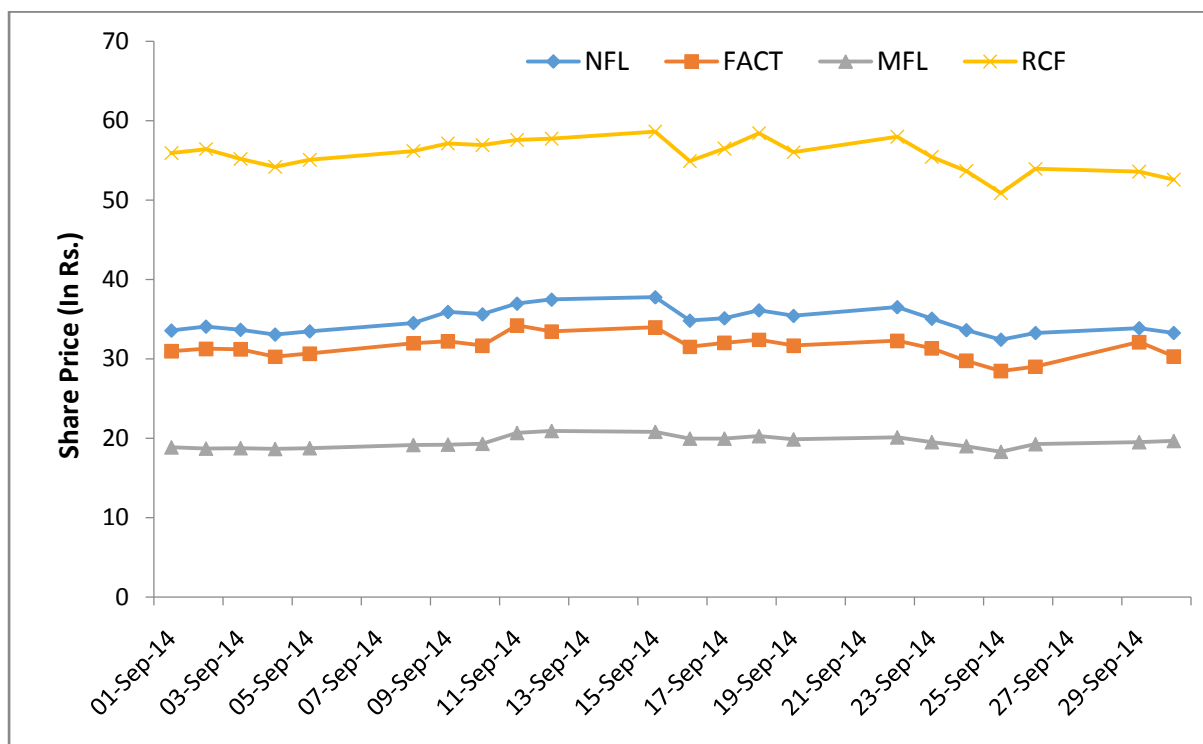
