**OFFICE MEMORANDUM**

Sub: Streamlining of Policy relating to SSP-the policy for marketing arrangement of SSP units with other fertilizer companies.

The undersigned is directed to refer to this Department O.M. of even number dated 11.08.2017 vide which the manufacturers were made eligible to claim subsidy under the marketing arrangement with one registered fertilizers company w.e.f. 01.07.2017. It was decided that it is not feasible to transfer data from marketers to manufacturers from retrospective date considering the usage of Retailer acknowledgement in balance payments to the marketers. The matter has been re-examined in the Department and the following has been decided with the approval of Competent Authority: -

- (i) Marketers is allowed to claim the subsidy (On account and balance) for the dispatches made from the SSP units till 31.12.2017 in one relaxation to the amendments issued in the SSP marketing policy vide OM dated 11.08.2017. The Department will not bear any additional burden on the marketer in form of any duty levied on the subsidies released under the above arrangement.
  - (i) Marketer will not enter data in iFMS related to raw material, production, dispatches and sales w.e.f. 01.01.2018. Any entry in this regard on and after 01.01.2018 on the marketer id will not be treated for the purpose of subsidy payment.
  - (ii) The Manufacturers will be allowed to claim the subsidy (On account and balance) w.e.f. 01.01.2018.
  - (iii) NIC will transfer the closing stock at plant as on 31.12.2017 of raw material, green SSP and finished fertilizers from the marketer id to the manufacturer id as opening stock on 01.01.2018 (the stock of finished fertilizers at all stock points other than plant will remain as the stock of marketer).
  - (iv) The system will be opened for all the SSP units under single marketing arrangements for the year 2017-18 to enter their data on iFMS from 01.01.2018 to as and when the system will be ready for the same.
