Subject : Implementation of the Nutrient Based Subsidy (NBS) Policy for Phosphatic & Potassic (P&K) fertilizers w.e.f. 1.4.2010 – Inclusion of NPKS complex fertilizer grades viz. 13-33-0-6S, MAP Lite 11-44-0-0 and DAP Lite grade (II) 14-46-0-0 w.e.f. 30.8.2011.

Madam/Sir,

I am directed to refer to the order dated 12.8.2011, issued by Department of Agriculture and Cooperation on the subject mentioned above. Accordingly, in pursuance of Clause 20 of the Fertilizer (Control) Order 1985, the Central Government has fixed the specifications in respect of the above mentioned fertilizers imported in India for a period of two years from the date of publication of the above said order in the official gazette for the purpose of sale of the same in India for the use of agriculture.

2. Department of Fertilizers has decided to include the imported NPKS complex fertilizer grades 13-33-0-6S, MAP Lite 11-44-0-0 and DAP Lite grade (II) 14-46-0-0 into the NBS w.e.f. 30.8.2011 for a period of one year.
3. Based on the notification No. 23011/1/2010-MPR (pt) dated 5.5.2011, the per metric tonne NBS for imported NPKS complex fertilizer grades mentioned above shall be as follows w.e.f. 30.8.2011:

Grades of Fertilizers	NBS w.e.f. 30.8.2011
13-33-0-6	14302
MAP Lite 11-44-0-0	17216
DAP Lite grade (II) 14-46-0-0	18677

4. All the terms and conditions of the NBS policy for import, production, sale and claim and payment of subsidy will apply.
5. This issues with the approval of the Hon'ble Minister (Chemicals & Fertilizers).
