 - (vii) Reserved Price fixed as Rs.31,000/-for the above said vehicle.
 - (viii) The quotations below the reserved price will not be entertained and liable to be rejected.

4. General Terms & Condition:-

1. Bidders may inspect the condemned staff car (No.DL 12C 1079 Ambassador) on the stipulated date and time.
4. The minimum price of the vehicle has been reserved at Rs.31000/-
5. The condemned staff car No.DL 12C 1079. shall be sold to the highest bidder.
4. The Earnest Money Deposit (EMD) of successful bidder shall be adjusted from the total payment.
5. The successful bidder has to make full balance payment after due adjustment of EMD in the form of Demand Draft in favour of Pay & Account Officer, Department of Fertilizers, Payable at New Delhi within three days after confirmation, failing which the offer will be cancelled and the EMD shall stand forfeited. The EMD of unsuccessful bidders shall be returned within one Month after the acceptance of auction bid, without any interest.
6. The Successful bidder will be required to lift all the items from the disposal site within three days after the payment of the balance amount. On failure to do so this office shall have the right to forfeit the entire amount of the bidder. On their own cost, the successful bidder will also be required to make his own arrangement of transportation, labour etc. for lifting the auctioned items.
7. The car once disposed to the successful bidder shall not be taken back by this Department on any condition whatsoever.
8. Quotation letter in the sealed envelope super subscribed ("TENDER FOR DISPOSAL OF CONDEMNED STAFF CAR No DL 12C 1079) should be addressed to **Smt. Geeta Mishra, Joint Director, FICC, 8th Floor, Sewa Bhawan, New Delhi-110066.**
9. The Quotation must be deposited/dropped in Tender Box kept at the Reception Office, Sewa Bhawan, New Delhi 110066 on or before the due date and time otherwise it shall be liable to be rejected. The Tenders received after the due date and time due to any reason whatsoever shall not be considered.
10. The financial bid quoted amount should be given in both in figures and words. Any overwriting or erasing in the figures shall not be considered for acceptance of the rates offered by the tenderer and the same will be summarily rejected. The figure quoted in words shall be deemed to be final in case of any discrepancy noted in the bid.
11. Deduction of applicable GST shall be indicated by this Department to the successful bidder. No representation shall be entertained from the successful bidder in this regard.

12. Department of Fertilizers (FICC) reserves the right to accept or reject any/all quotations without stating reason whatsoever. No representation in this regard shall be entertained from any of the bidder.
13. Each page of tender document should be signed by the bidder(s), failing which the bid will be summarily rejected.
14. Incomplete and unsigned bid is liable to be rejected.
15. Bidder must enclose copy of address proof (Voter I – Card/Adhaar Card/Driving License etc.) and Pan Card along with the bid.
16. An earnest Money Deposit (EMD) of Rs. 1000/- (One Thousand Only) must accompany the bid, without which the relevant bid shall summarily be rejected.
17. The purchaser will be responsible for future legal matter whatsoever, pertaining to the vehicle after taking delivery.
18. An undertaking regarding scraping of vehicle will have to be given by the successful bidder before taking possession of the vehicle and a letter will be sent to the Transport Authority to cancel the registration of the said vehicle.
